### VISION

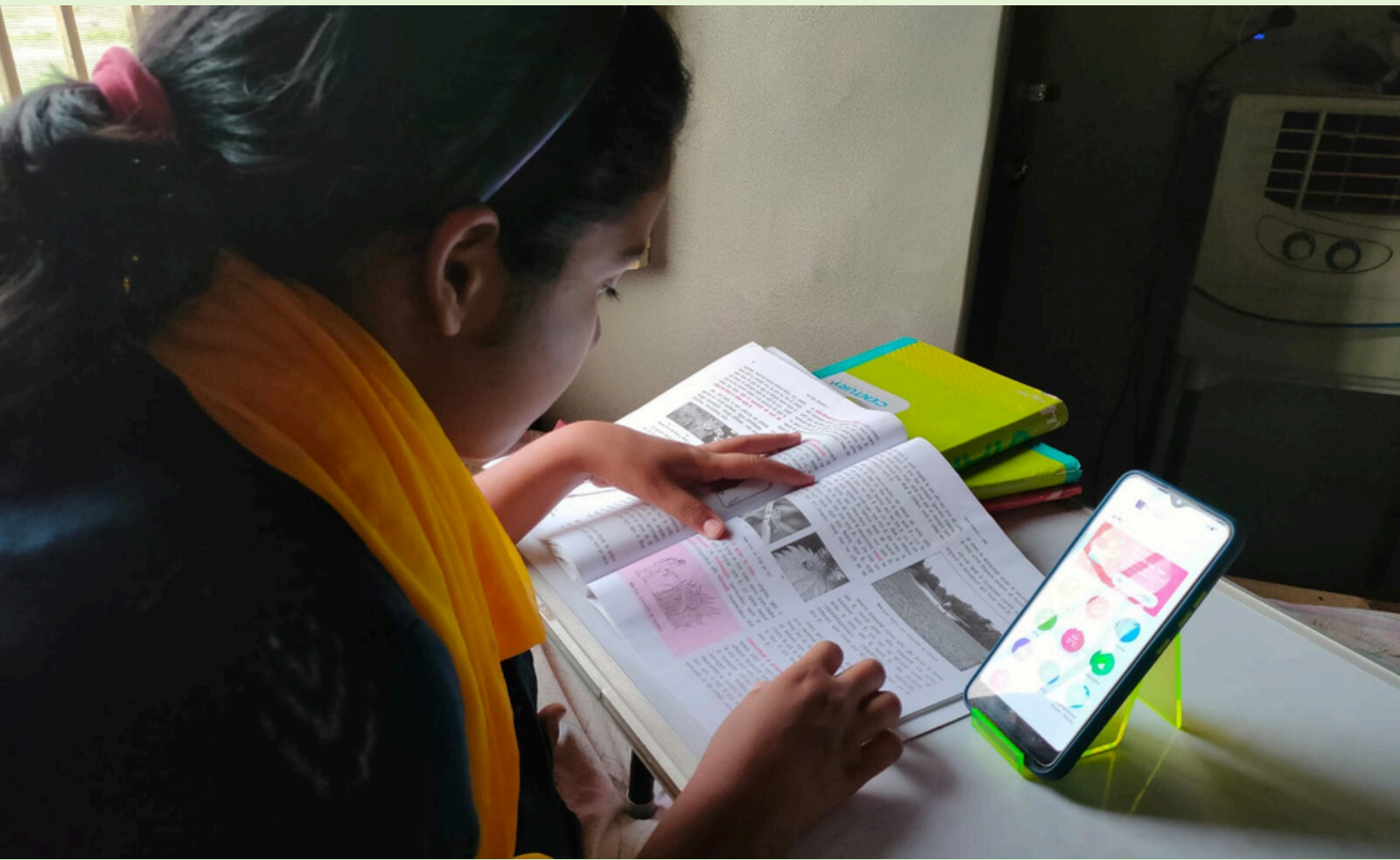

Duration: 1 Year

Direct Beneficiaries: 1021

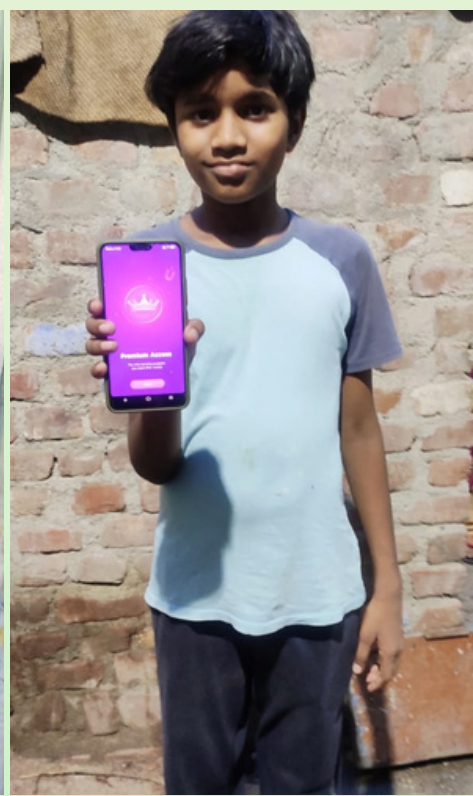
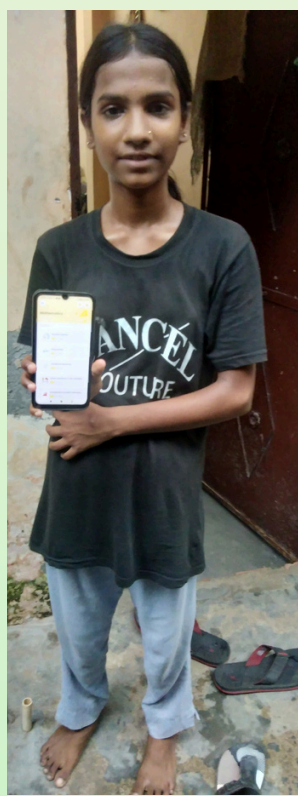
Location: Delhi, Uttarakhand, Bihar and Uttar Pradesh

Overview:

The Digital Education Initiative aimed to bridge the digital divide by providing essential educational resources and training to underserved communities. Through this program, we equipped individuals with digital literacy skills, enabling them to access educational content, enhance their learning, and improve their employment prospects.

Impact:

- 1021 students received digital education through digital learning platform (Byju App).
- Participants reported increased confidence in using digital tools and resources.
- Enhanced learning outcomes for students.





# DAAN UTSAV CLOTHES COLLECTION DRIVE

**Location:** New Delhi

**Date:** October-November 2022

**Direct Beneficiaries:** 5000

## Overview:

In celebration of Daan Utsav, also known as the Joy of Giving Week, we organized a clothes collection drive at prominent metro stations (Lajpat Nagar and South Extension metro stations) in collaboration with Delhi Metro. The initiative encouraged the community to donate clothes, which were then distributed to those in need.

## Impact:

- Collected and distributed clothing to 5000 individuals.
- Fostered a spirit of generosity and community involvement.
- Provided essential clothing to families and individuals, enhancing their quality of life.





# WINTER CLOTHES DISTRIBUTION

**Location:** Delhi NCR

**Date:** October 2022

**Direct Beneficiaries:** 370

## Overview:

As winter approached, we launched a distribution drive to provide warm clothing to those most vulnerable to the cold. This initiative targeted homeless individuals and low-income families across the Delhi NCR region.

## Impact:

- Distributed winter clothes to 370 individuals. Improved health and comfort for recipients during the harsh winter months.
- Raised awareness about the challenges faced by the homeless and impoverished during winter.





# CLOTHES COLLECTION DRIVES IN RESIDENTIAL AREAS

**Locations:** Gaur Green Vista, Ghaziabad; NBCC Flats, East Kidwai Nagar, Delhi

**Duration:** October – November 2022

**Direct Beneficiaries:** 2000

## Overview:

We organized clothes collection drives in residential complexes to gather donations from community members. These drives were instrumental in collecting a significant amount of clothing for redistribution.

## Impact:

- Benefited 2000 individuals through the distribution of collected clothes.
- Strengthened community ties and encouraged residents to participate in philanthropic activities.
- Ensured the provision of necessary clothing to underprivileged families.
